FIRE INVESTIGATOR RECERTIFICATION MANUAL

In a continued effort to reduce the fire loss in the State of North Carolina, the State Legislature established GS 58-278.31.14b, which required the State Fire and Rescue Commission to establish voluntary minimum professional qualifications for all levels of fire and rescue service personnel. It is the intent of this manual to set forth requirements pertaining to Fire Investigator Recertification. The following guide was established to assist personnel in making application to the Fire Investigator Review Board to be approved for recertification.

FIRE ARSON INVESTIGATOR RECERTIFICATION APPLICATION

Candidates for recertification are required to present 40 points, complete the attached application form and include with it a copy of supporting documentation. Additional information may be required by the Review Board. Please retain a copy for your records as the application packet will not be returned to you.

The type of training accepted for recertification must be that expected of a Certified Fire Arson Investigator. Examples of agency training meeting those guidelines are:

NC Department of Justice (SBI - NC Justice Academy)

IAAI or one of it's recognized chapters

Alcohol, Tobacco and Firearms (ATF)

Federal Law Enforcement Training Center (Georgia)

National Fire Academy

Federal Bureau of Investigation

Equivalent training meeting NFPA 1031 Fire Investigations standards taught by appropriate individuals or recognized experts as approved by the Board.

Please attach a copy of your resume and job description along with a letter from your supervisor outlining your duties.

The information supplied on the following pages and submitted for credit must have been achieved in the last five years, since your original certification date. Credit cannot be given for items achieved before your original certification.

For example, if you received a bachelor's degree prior to your original certification, you cannot credit that toward recertification. However, if you have achieved it since your original certification, or in the last five years, you may take credit for it.

The same rules apply for experience, i.e., you may only take credit for experience, classes taken, etc., that have occurred within the last five years.

Training, whether tested, non-tested or internet based for training hour credit must be of a level expected for a certified Fire Arson Investigator. For example, a class on introduction to fire investigation taught through a local fire department for fire personnel would be considered below the level expected of a fire investigator. Classes on clandestine drug labs, advanced investigation techniques, etc. are the type of courses expected for recertification. The board will not credit classes if they fall below the training level a certified investigator is expected to maintain.

I. Level of Education Achieved

Check only one of the following ten levels of education. Fields considered to be related to Fire Investigation are Engineering, Physical Sciences, Police Science and Criminal Justice. Fields not considered to be related are Education, Liberal Arts, etc. **Credit can only be taken for educational levels achieved in the last five years since your original certification date.**

- High School graduate, GED certificate or equivalent..... 10 points
- Associate Degree in field unrelated to fire investigation 12 points
- Associate Degree in field related to fire investigation 20 points
- Bachelors Degree in field unrelated to fire investigation 20 points
- Bachelors Degree in field related to fire investigation 30 points
- Masters Degree in field unrelated to fire investigation 25 points
- Masters Degree in field related to fire investigation 40 points
- Doctoral Degree in field unrelated to fire investigation 30 points
- L.L.B. or J.D..... 45 points
- Doctoral Degree in field related to fire investigation 50 points

IV. Professional Experience

List the total number of years experience for each category achieved since your last certification date as a Fire Arson Investigator. **No one year of experience can be carried over into more than one category.** Complete the shown multiplication process to determine points for each category and calculate the total in the space provided to the right. Credit for full-time fire investigation experience requires that fire investigation be a primary function in your job description. Investigations performed as a line officer, patrolman or adjuster cannot be claimed. Credit for supervision experience requires that you must have directly supervised the activities of the fire investigators assigned to your department. A department head cannot claim the supervision experience unless the fire investigators within that department report directly to the department head. A complete job description and a letter of certification from a supervisor, or equivalent documentation, must be submitted with the application.
