## SECTION 1

### Summary of Benefits

#### You have choices about how to get your Medicare benefits

- One choice is to get your Medicare benefits through Original Medicare (fee-for-service Medicare). Original Medicare is run directly by the Federal government.
- Another choice is to get your Medicare benefits by joining a Medicare health plan (such as **Humana Gold Plus H1036-137 (HMO)**).

### Who can join?

To join **Humana Gold Plus H1036-137 (HMO)**, you must be entitled to Medicare Part A, be enrolled in Medicare Part B, and live in our service area.

Our service area includes the following counties in North Carolina: Alexander, Anson, Burke, Cabarrus, Caldwell, Catawba, Gaston, Iredell, Lincoln, Mecklenburg, Rowan, Stanly, and Union.

### Which doctors, hospitals, and pharmacies can I use?

**Humana Gold Plus H1036-137 (HMO)** has a network of doctors, hospitals, pharmacies, and other providers. If you use the providers that are not in our network, the plan may not pay for these services.

You must generally use network pharmacies to fill your prescriptions for covered Part D drugs.

Some of our network pharmacies have preferred cost-sharing. You may pay less if you use these pharmacies.

### What do we cover?

Like all Medicare health plans, we cover everything that Original Medicare covers - and *more*.

- **Our plan members get *all* of the benefits covered by Original Medicare. For some of these benefits, you may pay more in our plan than you would in Original Medicare.** For others, you may pay less.
- **Our plan members also get *more than what is covered by Original Medicare*.** Some of the extra benefits are outlined in this booklet.

We cover Part D drugs. In addition, we cover Part B drugs such as chemotherapy and some drugs administered by your provider.

### How will I determine my drug costs?

Our plan groups each medication into one of five "tiers." You will need to use your formulary to locate what tier your drug is on to determine how much it will cost you. The amount you pay depends on the drug's tier and what stage of the benefit you have reached. Later in this document we discuss the benefit stages that occur after you meet your deductible: Initial Coverage, Coverage Gap, and Catastrophic Coverage.

### Summary of Benefits January 1, 2015 - December 31, 2015

#### Monthly Premium, Deductible, and Limits on How Much You Pay for Covered Services

<b>How much is the monthly premium?</b>	<b>\$0</b> per month. In addition, you must keep paying your Medicare Part B premium.
<b>How much is the deductible?</b>	<b>\$320</b> per year for Part D prescription drugs.
<b>Is there any limit on how much I will pay for my covered services?</b>	Yes. Like all Medicare health plans, our plan protects you by having yearly limits on your out-of-pocket costs for medical and hospital care. Your yearly limit(s) in this plan: <ul style="list-style-type: none"><li>• <b>\$5,300</b> for services you receive from in-network providers.</li></ul> If you reach the limit on out-of-pocket costs, you keep getting covered hospital and medical services and we will pay the full cost for the rest of the year. Please note that you will still need to pay your monthly premiums and cost-sharing for your Part D prescription drugs.
<b>Is there a limit on how much the plan will pay?</b>	Our plan has a coverage limit every year for certain in-network benefits. Contact us for the services that apply.

Humana is a Medicare Advantage HMO plan with a Medicare contract. Enrollment in this Humana plan depends on contract renewal.

Days' Supply Available

Unless otherwise specified, you can get your Part D medicine in the following days' supply:

- One-month supply= up to 30 days\*
- Two-month supply= 31-60 days
- Three-month supply= 61-90 days

\*Long Term Care Pharmacy (one month supply= 31 days)

### Coverage Gap

Most Medicare drug plans have a coverage gap (also called the "donut hole"). This means that there's a temporary change in what you will pay for your drugs. The coverage gap begins after the total yearly drug cost (including what our plan has paid and what you have paid) reaches **\$2,960**.

After you enter the coverage gap, you pay **45%** of the plan's cost for covered brand name drugs and **65%** of the plan's cost for covered generic drugs until your costs total **\$4,700**, which is the end of the coverage gap. Not everyone will enter the coverage gap. Under this plan, you may pay even less for the brand and generic drugs on the formulary. Your cost varies by tier. You will need to use your formulary to locate your drug's tier. See the chart that follows to find out how much it will cost you

**Catastrophic Coverage**

After your yearly out-of-pocket drug costs (including drugs purchased through your retail pharmacy and through mail order) reach **\$4,700**, you pay the greater of:

- **\$2.65** copay for generic (including brand drugs treated as generic) and a **\$6.60** copayment for all other drugs

### Adding Benefits to Your Plan

You're unique and have unique needs for staying healthy. That's why Humana offers optional supplemental benefits. For an extra premium, each of these extra benefit choices lets you customize your Humana Medicare Advantage plan.

These benefits make it easier for you to get more coverage when you need it. They can also help you control your costs.

You can add these extra benefits when you sign up for your Medicare Advantage plan or any time during the year.

### MyOption<sup>SM</sup> Dental – High PPO

The MyOption<sup>SM</sup> Dental – High PPO benefit makes it easy for you to plan for your dental care. The benefit has a **\$50** deductible and **100 percent** coverage for two routine exams per year with an in-network provider.

The benefit covers some of the cost for basic procedures, like fillings and extractions (pulling teeth). It can also help pay for major services, like crowns and dentures. There's a maximum annual benefit of **\$1,500**, and there's no waiting period before your coverage begins. The premium for this OSB is **\$15.70**. Here's how the benefit works:
