Variable Life and Variable Annuity Agent	No	Apply on-line at <a href="http://www.nipr.com">www.nipr.com</a> and pay \$50 registration fee.
Medicare Supplement/Long-Term Care Agent	No	Must be licensed for Accident and Health or Sickness. Apply on-line at <a href="http://www.nipr.com">www.nipr.com</a> and pay \$50 registration fee.

Broker	No	Must be licensed as an agent for the lines of authority to be brokered and have at least one appointment. Must secure and maintain a \$15,000 surety bond. Submit NAIC uniform application, surety bond and power of attorney.  Apply on-line at <a href="http://www.nipr.com">www.nipr.com</a> and pay \$50 registration fee.
Viatical Broker	No	Apply on-line at <a href="http://www.nipr.com">www.nipr.com</a> and pay \$500 registration fee.
Company/Independent Firm Adjuster	No	Apply on-line at <a href="http://www.nipr.com">www.nipr.com</a> and pay \$75 registration fee.
Self-Employed Adjuster	No	Apply on-line at <a href="http://www.nipr.com">www.nipr.com</a> and pay \$125 fee.  If applicant's state of residence does not issue adjuster's license or applicant is not licensed as an adjuster in another state, he must pass the North Carolina state examination.
Public Adjuster	No	Apply on-line at <a href="http://www.nipr.com">www.nipr.com</a> and pay \$75 registration fee.  If applicant's state of residence does not issue adjuster's license or applicant is not licensed as an adjuster in another state, he must pass the North Carolina state examination.
Hail Adjuster	No	Apply on-line at <a href="http://www.nipr.com">www.nipr.com</a> and pay \$75 registration fee.  If applicant's state of residence does not issue adjuster's license or applicant is not licensed as an adjuster in another state, he must pass the North Carolina state examination.
Motor-Vehicle Damage Appraiser	No	Apply on-line at <a href="http://www.nipr.com">www.nipr.com</a> and pay \$125 registration fee.
Purchasing Group/Risk Retention Group	No	Must be licensed for Property/Liability. Must secure and maintain \$10,000 surety bond. <i>No bond is required for Risk Retention Groups.</i> Group must be registered through the Department's Financial Evaluation Division. Submit NC-pg application, surety bond, and power of attorney with \$50 fee.
