2014 NC Electrical Code Update

The 2014 NEC with North Carolina Amendments was adopted by the Building code council on 12/15/2015, with a 4/1/2016 effective date. Remember, **effective** date means it **shall** be used on and after that date. Typically this would mean all projects with a permit issue date of April 1st and after would use the 2014 NEC with NC Amendments. Contact local permitting office for clarifications on projects already under review prior to the April 1st date. See following link for BCC minutes.

Model Code Development – ICC Published Results

As discussed in previous newsletters, the Model Code that North Carolina uses as the base document for the NC building codes and trade codes (except Electrical) is updated every three years. States, cities and other jurisdictions outside of NC adopt them at various intervals as they see fit. The proposals to the model codes, and the reasons for the proposal and subsequent rebuttals, can be viewed on-line for the more recent code cycles. Older code cycles (pre-2006) are not available on-line, contact ICC to obtain records. In researching the "why" behind a code change, it is sometimes helpful to view the proposer's back-up data. Even for new code proposals, if nothing changes, many times the discussion reveals technical reasons that may have been not been obvious before. Of course, only the changes made to the model codes are available for review on this website. Changes to the NC code would have to be done by reviewing archived Building Code Council proposed changes.

Training Summary

A review of the Standard Course offerings for July 2015 – December 2016 showed nearly 540 student names were submitted on 65 class rosters for F,B,M,E,P (excluding Law and Admin courses). This is an average of about 8.3 students per class. With classes this small, the community colleges have a challenging time justifying offering the classes, and classes may get canceled and rescheduled for a later date. Please note one person could be attending multiple classes, so the number of courses taken does not indicate the number of code enforcement personnel. Of the 58 community colleges in NC, about 22 offer Standard

Courses. These classes are open to the public, and are an excellent chance for anyone associated with the building trade to obtain the same basic training a code official receives.
